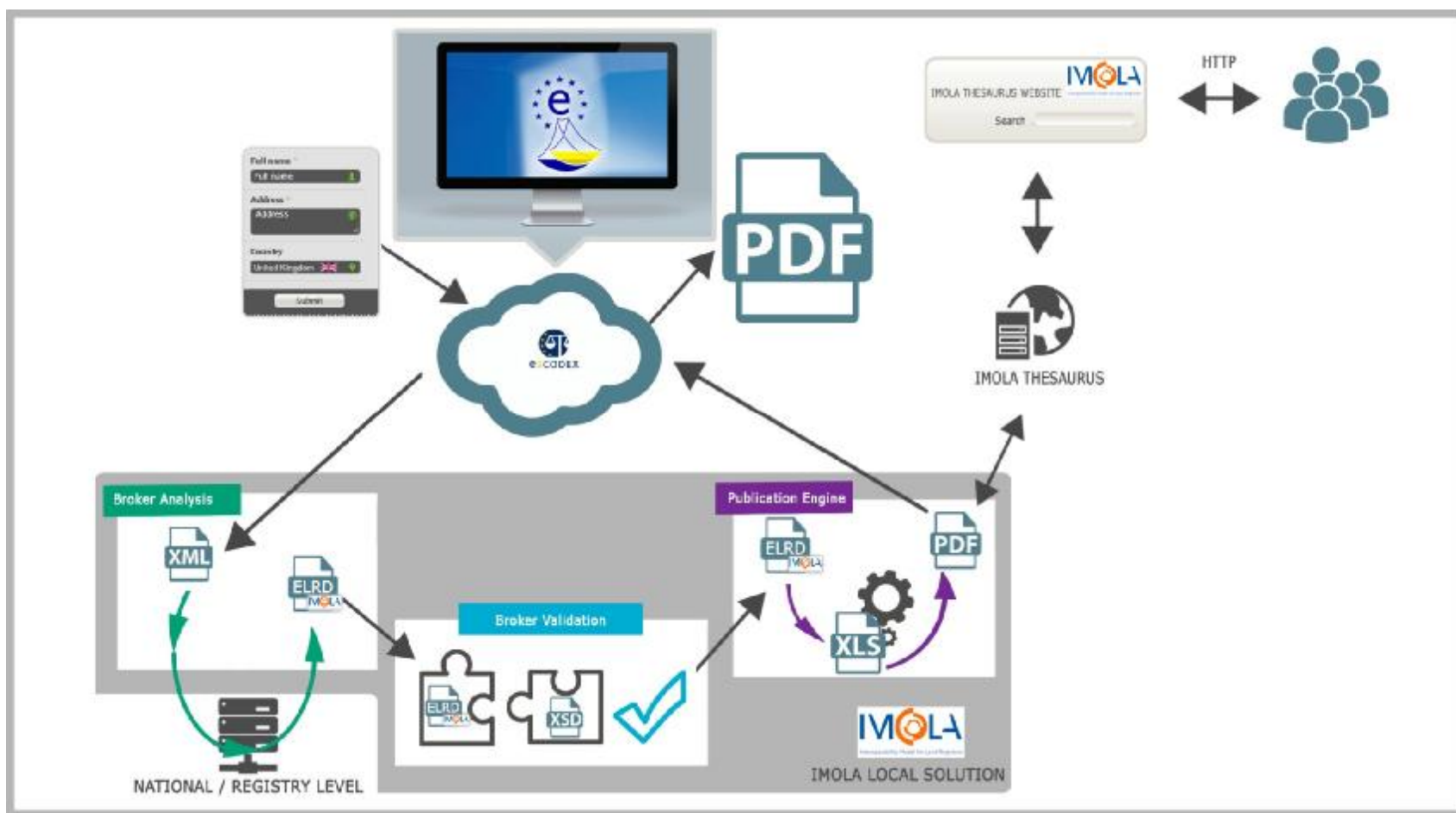

10/2015	DG JUST submits Business Case to COM IT Board
10/2015	IT Board evaluates "Positive with conditions"
11/2015	Call for Tenders for LRI is issued for IT consortium
1/2016	DG JUST submits Project Charter to IT Board
1/2016	1 st Meeting of Experts for LRI
7/2016	Selected IT consortium from Tender starts work
9/2016	2 nd Meeting of Experts for LRI





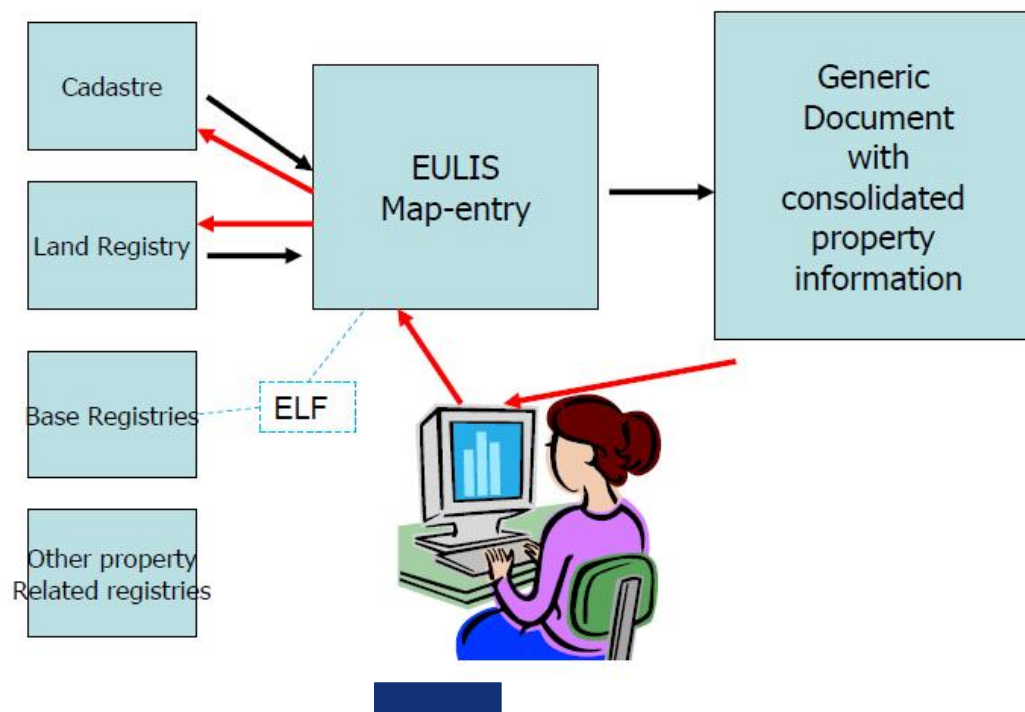

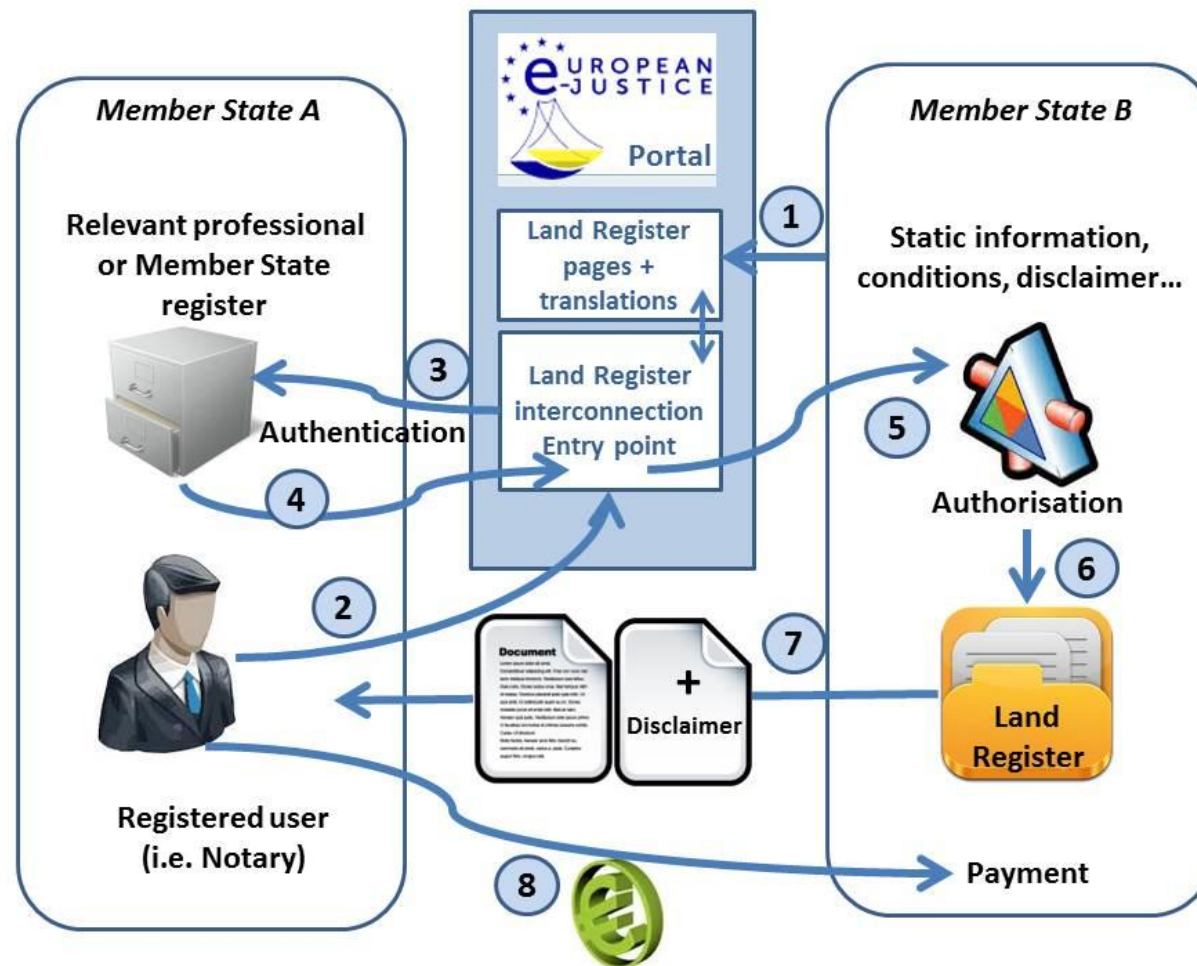

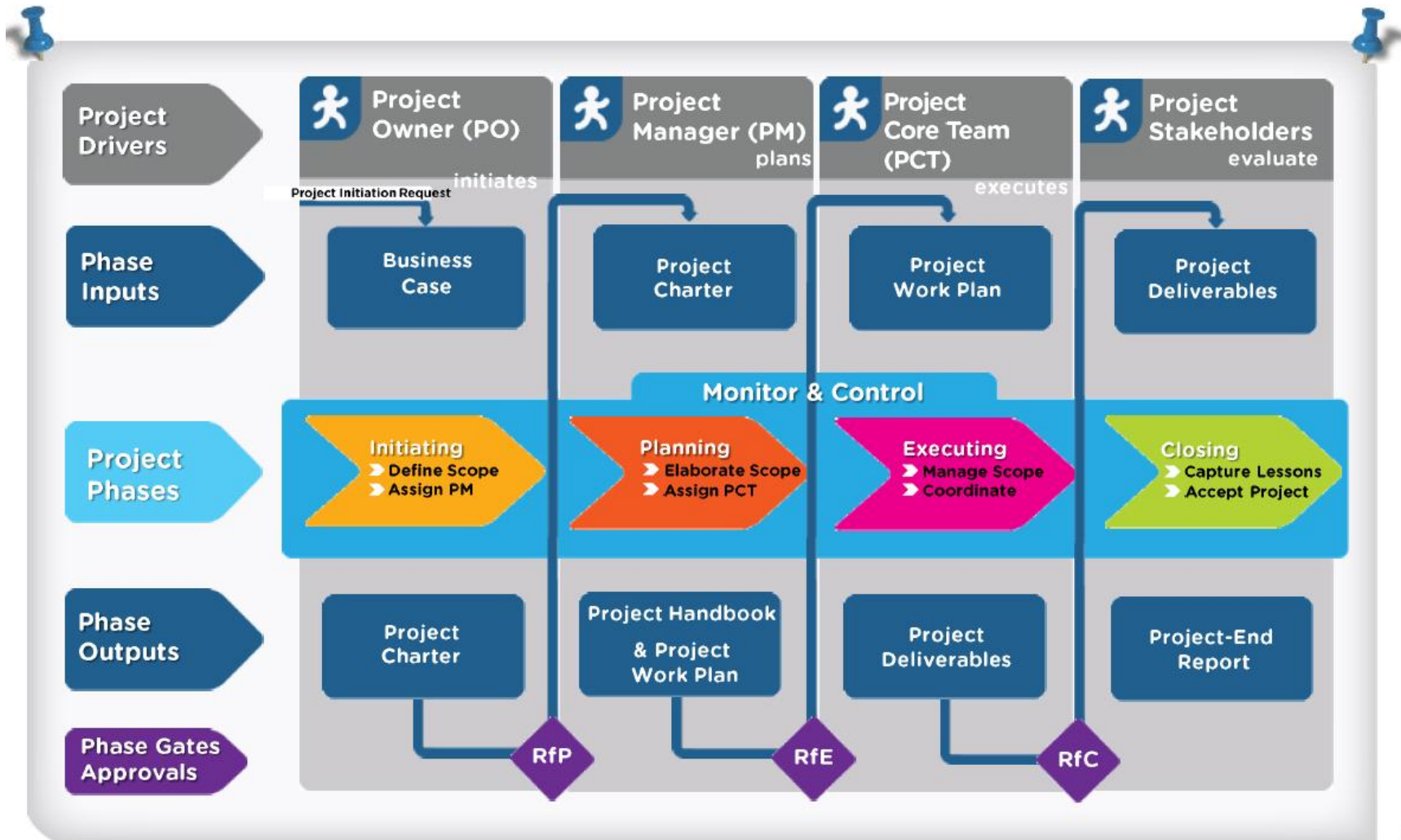

 - Tendering process for selecting IT consortium
 - Analysis for Payment Service Provider (PSP)
